## SAFETY PRECAUTIONS

---

Electricity is used to perform many useful functions, but it can also cause personal injuries and property damage if improperly handled. This product has been engineered and manufactured with the highest priority on safety. However, improper use can result in electric shock and/or fire. In order to prevent potential danger, please observe the following instructions when installing, operating and cleaning the product. To ensure your safety and prolong the service life of your LCD product, please read the following precautions carefully before using the product.

1. Read instructions — All operating instructions must be read and understood before the product is operated.
2. Keep this manual in a safe place — These safety and operating instructions must be kept in a safe place for future reference.
3. Observe warnings — All warnings on the product and in the instructions must be observed closely.
4. Follow instructions — All operating instructions must be followed.
5. Cleaning — Unplug the power cord from the AC outlet before cleaning the product. Use a dry cloth to clean the product. Do not use liquid cleaners or aerosol cleaners.
6. Attachments — Do not use attachments not recommended by the manufacturer. Use of inadequate attachments can result in accidents.
7. Water and moisture — Do not use the product near water. Do not install the product in a place where water may splash onto it. Be careful of equipment which drains water such as an air-conditioner.
8. Ventilation — The vents and other openings in the cabinet are designed for ventilation. - Do not display a still picture for a long period, as this could cause a residual image.
- Never rub or tap the monitor with hard objects.
- Please understand that SHARP CORPORATION bears no responsibility for errors made during use by the customer or a third party, nor for any other malfunctions or damage to this product arising during use, except where indemnity liability is recognized under law.
- This monitor and its accessories may be upgraded without advance notice.
- Do not use the monitor where there is a lot of dust, where humidity is high, or where the monitor may come into contact with oil or steam. 


# MOUNTING PRECAUTIONS

- A mounting bracket compliant with VESA specifications is required.
- Since the monitor is heavy, consult your dealer before installing, removing or moving the monitor.
- Mounting the monitor on the wall requires special expertise and the work must be performed by an authorized SHARP dealer. You should never attempt to perform any of this work yourself. Our company will bear no responsibility for accidents or injuries caused by improper mounting or mishandling.
- Use the monitor with the surface perpendicular to a level surface. If necessary, the monitor may be tilted up to 20 degrees upward or downward.
- This monitor should be used at an ambient temperature between 32°F (0°C) and 104°F (40°C). Provide enough space around the monitor to prevent heat from accumulating inside.





- Temperature condition may change when using the monitor together with the optional equipments recommended by SHARP. In such cases, please check the temperature condition specified by the optional equipments.
- Do not block any ventilation openings. If the temperature inside the monitor rises, this could lead to a malfunction.
- Do not place the monitor on a device which generates heat.





# Connecting Peripheral Equipment



## ! Caution

- Be sure to turn off the main power switch and disconnect the plug from the power outlet before connecting/ disconnecting cables. Also, read the manual of the equipment to be connected.
- Be careful not to confuse the input terminal with the output terminal when connecting cables. Accidentally reversing cables connected to the input and output terminals may cause malfunctions and the other problems.
- Do not use any cable that has a damaged or deformed terminal. Using such cables may cause malfunctions.

## TIPS


- Images may not be displayed properly depending on the computer (video card) to be connected.
- Perform automatic adjustment using SCREEN POSITION of INPUT SELECT in the SETUP menu when a PC screen is displayed using D-SUB, or when the setting of the PC is changed.
- If the audio output from the playback device is connected directly to speakers or other devices, the video on the monitor may appear delayed from the audio portion. Audio should be played through this monitor by connecting the playback device to the monitor's audio input, and connecting the monitor's audio output to the speakers or other devices.

## Connection with a PC or AV equipment

1. HDMI1 input terminal
2. HDMI2 input terminal
3. HDMI3 input terminal
4. HDMI4 input terminal

- Connect with a commercially available HDMI certified cable. For the following, use a high-speed HDMI cable:
  - When connecting a device that is compatible with 4K2K output.
  - When inputting a 1080p video signal
- The HDMI1 input terminal is compatible with ARC (Audio Return Channel). To connect an ARC-compatible audio device using an HDMI cable, connect to the HDMI1 input terminal.
- When using the audio input terminal with HDMI input, use the HDMI3 input terminal and set AUDIO SELECT of INPUT SELECT in the SETUP menu to HDMI + ANALOG.
- The HDMI4 input terminal is compatible with MHL (Mobile High-Definition Link). An MHL-compatible smartphone can be connected using a commercially available MHL cable to show video from the smartphone on the monitor while charging the smartphone. When a MHL is connect, the input is automatically switched to HDMI4. This product supports MHL1.
  - Compatible copyright protection signals
    - HDMI1 - 3 input terminals: HDCP1.4
    - HDMI4 input terminal: HDCP2.2
- When the connection between HDMI1 to HDMI3 and HDMI4 is switched, it could be necessary to reconfigure the computer.
- For a 3840 × 2160 (60 Hz) video signal
  - HDMI1 - 3 input terminals are compatible with 4:4:4, 4:2:2, and 4:2:0 formats.
  - HDMI4 input terminal is only compatible with 4:2:0 format.
  - If input in 4:4:4 format is not necessary, use the HDMI4 input terminal. If an HDMI1 - 3 input terminal is used, the video or audio may not be output correctly.

- Compatible audio signals
  - Type: Linear PCM (2 ch), AAC, Dolby Digital
  - Sampling frequency: 48kHz / 44.1kHz / 32kHz
- Use an HDMI cable connector with the following dimensions:



### 5. PC D-sub input terminal

- When using the audio input terminal with the PC D-sub input terminal, set AUDIO SELECT of INPUT SELECT in the SETUP menu to VIDEO + AUDIO.
- When using the PC D-sub input terminal, space is required behind the monitor.

### 6. USB port

- Connect a USB flash drive to the USB port.
- Do not connect a USB device other than a USB flash drive.
- Turn off the power of the monitor when removing a USB flash drive.

#### Supported USB flash drives

Capacity	Up to 32 GB (maximum file size 2 GB)

- Do not use a USB flash drive with a security function or a write protection function.
- Use a USB flash drive with a shape that can be inserted in the USB port. Some USB flash drives with special shapes cannot be inserted. Do not forcibly insert a USB flash drive. This may damage the connector and cause failure.

### 7. Audio input terminal


- This is used to input analog audio when video is shown using the HDMI3 input terminal or the PC D-sub input terminal. Check the setting in AUDIO SELECT of INPUT SELECT in the SETUP menu.
- Use an audio cable without resistance.

### 8. Headphone terminal

- Use commercially available headphones (mini stereo jack).
- The output sound varies depending on the input mode.
- The volume can be adjusted using the volume adjustment.
- When headphones are connected to the headphone terminal, sound is not output from the monitor speakers.

### 9. Digital audio output (optical) terminal

- You can output MPEG2 AAC / Dolby Digital audio format from the monitor.
- Use the following for the digital audio output (optical) terminal.



### 10. CONTROL terminal (RS-232C input terminal)

# Preparing the Remote Control Unit

## Installing the batteries

2. See the instructions in the compartment and put in the supplied batteries (LR-6 ("AA" size) x 2) with their plus (+) and minus (-) sides oriented correctly.
3. Close the cover.

### TIPS

- When the batteries become exhausted, replace them with new (commercially available) batteries.
- The supplied batteries (LR-6 ("AA" size) x 2) may become exhausted quickly depending on how they are stored.
- If you will not be using the remote control for a long time, remove the batteries.
- Use manganese or alkaline batteries only.



### TIPS


- Do not expose the remote control unit to shock by dropping or stepping on it. This could lead to a malfunction.
- Do not expose the remote control unit to liquids, and do not place it in an area with high humidity.
- The remote control unit may not work properly if the remote control sensor is under direct sunlight or strong lighting.
- Objects between the remote control unit and the remote control sensor may prevent proper operation.
- Replace the batteries when they run low as this may shorten the remote control's operation range.
- If a fluorescent light is illuminated near the remote control unit, it may interfere with proper operation.
- Do not use it with the remote control of other equipment such as air conditioner, stereo components, etc.







## 2. MUTE

- sRGB is international standard of color representation specified by IEC (International Electrotechnical Commission). Color conversion is made in taking account of liquid crystal's characteristics and represents color tone close to its original image.

## 9. SIZE/F3 (Screen size selection)

## ■ Switching the screen size

Even when the screen size is changed, the display may remain the same depending on the input signal.

<b>NORMAL</b>		Displays image so it fills the screen without changing the aspect ratio of the input signals.
<b>WIDE</b>		Displays image so it fills the entire screen.
<b>DOT BY DOT</b>		Displays the dots of the signals input from the connected PC as the corresponding dots on the screen. When the image resolution is 1920x1080 pixels or lower, the image is expanded to twice the height and width of the original.
<b>UNDERSCAN</b>		Displays the image of the input signal without modification.
<b>ZOOM</b>		Displays a CinemaScope or 16:9 size video content in full-screen mode.

### TIPS

- Using this monitor's screen-size switching or dual-screen display functions to compress or expand the screen for commercial or public viewing in establishments like cafes or hotels may infringe on the rights of the creators, as protected by Copyright Law, so please be careful.
- The appearance of the original video may change if you select a screen size with a different aspect ratio than the original image (e.g. TV broadcast or video input from external equipment).
- When an ordinary non-wide image (4:3) is viewed with the whole screen using the screen-size switching function of this monitor, the edge of the image may be lost or appear distorted. If you wish to respect the creator's intentions, set the screen size to "NORMAL".
- When playing commercial software, parts of the image (like subtitles) may be cropped. In this case select the optimal screen size using the screen-size switching function of this monitor. With some software, there may be noise or distortion at the edges of the screen. This is due to the characteristics of the software, and is not a malfunction.
- Depending on the original image size, black bands may remain at the edges of the screen.
- Input signals under 4K2K resolution are displayed in 3840 x 2160 resolution level by upscaling. (Except for DOT BY DOT)

- In a portrait installation, a portrait photo may occasionally appear in landscape orientation. If this occurs, set the EXIF information (rotation information) in the file to no rotation using an image processing program on your computer.

## Menu item details

The menu will differ depending on the input mode and the items that can be set vary depending on the mode.

### ■ PICTURE

#### **PICTURE MODE**

Changes the picture mode on the screen. The picture mode on the screen can also be changed using a remote control unit. (See page 18.)

#### **BRIGHT**

Adjusts the backlight brightness.

#### **CONTRAST**

Adjusts the difference between the bright and dark portions of the image.

#### **BLACK LEVEL**

Adjusts the entire brightness of the video signals.

#### **TINT**

Adjusts the hue. Selecting + changes the color towards green, and selecting - changes it towards magenta.

#### **COLORS**

Adjusts the color intensity.

#### **SHARPNESS**

Adjusts the sharpness of the image.

#### **COLOR ADJUSTMENT**

##### **C.M.S.-HUE**

Adjusts color tone with 6 colors of R (red), Y (yellow), G (green), C (cyan), B (blue), and M (magenta).

##### **C.M.S.-SATURATION**

Adjusts color vividness with 6 colors of R (red), Y (yellow), G (green), C (cyan), B (blue), and M (magenta).

##### **C.M.S.-VALUE**

Adjusts color brightness with 6 colors of R (red), Y (yellow), G (green), C (cyan), B (blue), and M (magenta).

##### **WHITE BALANCE**

Adjusts from a bluish white (color temperature: 12000K) to a reddish white (color temperature: 3000K). You can also change the R gain, G gain, and B gain values for each color temperature to perform fine adjustment of the white balance.

##### **GAMMA ADJUSTMENT**

Adjusts the gradation difference between bright parts and dark parts of video.

## Menu Items

### ADVANCED

#### **QUICK SHOOT**

- ADVANCED(HIGH), ADVANCED(LOW)..... Using interpolation, this shows video that is normally shown at 60 frames/sec at 120 frames/sec for a smoother picture. However, this may distort the picture of some videos. In this case, set to STANDARD or OFF.
- STANDARD..... This makes scenes with fast action clearer and easier to view.

#### **ACTIVE CONTRAST**

- Automatically adjusts the contrast according to the image.  
The adjustment operation may not be smooth depending on the image. In this case select OFF.

#### **RESOLUTION**

- Adjusts the fineness of the image.

#### **MULTI PIXEL DRIVE**

- Adjusts the gradation to widen the angle of view.

#### **PIXEL DIMMING**

- Adjusts the contrast of the video.

#### **FILM MODE**

- Adjusts so the input signal is video at 24 frames per second.  
ADVANCED(HIGH), ADVANCED(LOW).... Play at high-quality for smooth video movement.  
STANDARD..... Play video with each frame shown an equal amount of time.

#### **DIGITAL NR**

- Reduces block noise caused by digital compression.

#### **MONOCHROME**

- Sets the video to black & white.

### RESET

Resets the values of current picture mode items in PICTURE menu to the factory preset values.

## ■AUDIO

### TREBLE

Adjusts the volume of treble-level sound.

### BASS

Adjusts the volume of bass-level sound.

### BALANCE

Adjusts the balance of the audio sound between right and left.

### BAND EXTENSION

Adjusts so that low range and extended range audio from the speakers can be easily heard.

### RESET

Resets the values of the AUDIO menu items to the factory preset values.

**■SETUP****LANGUAGE**

Sets the display language for the menu screen.

**SLEEP TIMER**

When the set time elapses, the monitor automatically enters standby mode. This can be set to up to 23 hours in increments of one hour.

**INPUT SELECT****HDMI SETTING**

- HDMI CEC LINK .....When AUTO is selected, HDMI CEC LINK is enabled and the HDMI input terminal changes when playback is started on an external device. When OFF is selected, AUTO POWER ON and AUDIO RETURN CHANNEL cannot be selected.
- AUTO POWER ON .....Sets whether the monitor power turns on when the power of an external device is turned on.
- AUDIO RETURN CHANNEL.....When HDMI1 input is used, sets whether the monitor audio is output from compatible devices via HDMI cable.
- POSITION .....Adjusts the horizontal and vertical position of the image.
- HDMI AUTO WIDE  
 AUTO MODE.....Automatically changes the screen size to ZOOM if a black band appears at the top and bottom of the input video.
- HDMI SIGNAL .....Sets to ENABLE to have the screen size change automatically according to the screen size control signal included in the video signal input from the HDMI input terminal.

**SCREEN POSITION (D-SUB)**

- INPUT SIGNAL .....When the input signal is 1024 x 768 or 1366 x 768 in PC D-sub, select to match the resolution.
- AUTO SYNC. ....When YES is selected, H-POS., V-POS., CLOCK, and PHASE are automatically adjusted. Use this automatic adjustment when you use the PC D-Sub to display a PC screen or when you change the setting of the PC. (See page 29.)
- SCREEN POSITION.....Adjusts H-POS. (Position of the longest direction), V-POS. (Position of the shortest direction), CLOCK, and PHASE. To restore the factory default settings, use RESET.

**INPUT SKIP**

- AUTO .....Skips when the terminal is not connected.
- ON.....Always skips.
- OFF .....Always enable selection of the input.
- Settings in INPUT SKIP are displayed in the input mode selection screen. (SELECTABLE/NOT SELECTABLE)

Changes the display names of input mode.

Selects the installation direction of the monitor.

LANDSCAPE .....Landscape orientation

PORTRAIT .....Portrait orientation. MULTIMEDIA (see page 20) always remains in landscape orientation.

\* If video is upside down when the monitor is installed in the portrait orientation, you can rotate the video 180 degrees with PORTRAIT ROTATE (see page 30) in the FUNCTION menu. When this is done, the MONITOR setting cannot be changed.

### STANDBY MODE

When STANDARD is selected, startup time from standby mode is reduced. Note, however that, more power will be consumed in standby mode.

When LOW POWER is selected, current consumption is reduced while the monitor is in standby mode. Note, however, that the startup time from standby mode becomes longer.

If set to LOW POWER, control via LAN cannot be performed in standby mode.

### OFF IF NO OPERATION

Determines whether or not to set the monitor to go into standby mode when there is no operation from the remote control unit, control commands, or LAN for over 4 hours.

### OFF IF NO SIGNAL

Sets whether or not the monitor enters the power standby state when there is no input signal for more than 5 minutes.

Sets the media used for auto play. (See page 22.)

### SOFTWARE VERSION

Shows the software version, etc.

### SOFTWARE UPDATE

You can update the software.

### SETTING RESET

Resets the settings to the factory default settings.

\* Photo files copied to INTERNAL MEMORY with MULTIMEDIA will not be erased.

## Character input

For items that require entry of text, press  to display the software keyboard.

Select a character with    , and press  to enter.

- To change the characters entered, select CHAR. SET or press  (F1).
- To switch between upper case and lower case, select CAPS and press .
- To delete characters, select CLEAR or DELETE and press . You can also perform DELETE by pressing  (F2).
- When you are done entering characters, select DONE and press .

You can also finish by pressing  (F3).

To cancel character entry, select CANCEL and press .

## Adjustments for PC screen display

### ■ Automatic adjustment

When you use the PC D-sub to display a PC screen, or when you change the setting of the PC, use the automatic screen adjustment.







Connect the COM port on the PC (RS-232C connector) to the CONTROL terminal (RS-232C input terminal) on the monitor using the RS-232C conversion cable (supplied) and an RS-232 straight cable (commercially available).

# Controlling the Monitor with a PC (LAN)

Your monitor can be connected to a LAN allowing you to control it from a PC on the LAN.

The connection requires a commercially available LAN cable (UTP cable, Category 5, straight through).



## TIPS

- You must assign an IP address to the monitor by following the procedures in “Settings to connect to a LAN”. (See the description on the right.)
- To control the monitor via LAN, set IP CONTROL SETUP to ENABLE. (See page 37.)
- You cannot use RS-232C and LAN control simultaneously.
- When STANDBY MODE is LOW POWER, control is not possible in the power standby state.

## Settings to connect to a LAN

Set LAN SETUP and IP CONTROL SETUP in COMMUNICATION SETTING in the SETUP menu. (See page 28.)

The settings depend on the configuration of your LAN. Ask your LAN administrator for details.

### LAN SETUP

1. Display the current LAN information.
2. If you need to change the setup, select **CHANGE** or **INITIALIZE** with  or , and press .  
CHANGE: Change the LAN setup. See the step 3.  
INITIALIZE: Reset the current settings.

3. Set the IP address.

Select YES or NO with  or , and press .

#### YES

Acquire the IP address automatically.

#### NO

Enter the IP ADDRESS, NETMASK, and GATEWAY with the software keyboard. (See page 29.)

When NO is selected, YES (auto acquisition of DNS IP address) cannot be selected in step 5.

4. Select **NEXT**, and press .

5. Set the IP address of the DNS server.

Select YES or NO with  or , and press .

#### YES

Acquire the IP address of the DNS automatically. (Use the DHCP server function of your network environment.)

#### NO

Enter the PRIMARY and SECONDARY IP addresses with the software keyboard. (See page 29.) For the values to be entered in each field, check the specifications of your network environment.

6. Select **NEXT**, and press .

7. Select **TEST** with  or , and press .

8. Check your settings, select **COMPLETE** with  or , and press .

### ■ IP CONTROL SETUP

#### 1. Set IP control to ENABLE.

Select IP CONTROL SETUP with  or  and press . Select CHANGE and press . Select ENABLE with  or  and press .

#### 2. Configure advanced security settings.

Select DETAIL SETTING with  or  and press . Select CHANGE with  or  and press .

#### 3. Set the login information.

Enter the LOGIN ID and PASSWORD with the software keyboard (see page 29).

#### 4. Select NEXT and press .

#### 5. Set the control port.

Enter the CONTROL PORT with the software keyboard (see page 29).

#### 6. Select NEXT and press .

#### 7. Check your settings, select COMPLETE with or , and press .

### Command-based control

You can control the monitor using control commands (see page 33) via terminal software and other appropriate applications.

Read the manual for the terminal software for detailed instructions.

#### (1) Connect the PC to the monitor.

Use a commercially available LAN cable to connect a PC to the monitor. (See page 36.)

#### (2) Send commands to control the monitor.

- The commands used are the same as those for RS-232C. Refer to the communication procedure (see page 31) for operation.
- Usable commands are provided in the control command table (see page 33).

# Troubleshooting

If you are experiencing any problem with your display, before calling for service, please review the following troubleshooting tips.

## **There is no picture or sound.**

- Is the power cord disconnected? (See page 14.)
- Is the main power switch off? (See page 17.)
- Is the monitor in standby mode (the power LED illuminating in orange)? (See page 17.)
- Make sure correct input mode is selected. (See page 18.)
- If any external equipment is connected, make sure the equipment is operating (playing back).

## **Remote control does not work.**

- Are the batteries inserted with polarity (+,-) aligned? (See page 16.)
- Are the batteries exhausted?
- Point the remote control unit toward the monitor's remote control sensor. (See page 16.)
- Is ON SCREEN DISPLAY set to OFF or is operation disabled? (See page 30.)

## **Sound is heard from only one side.**

- Are audio cables connected properly?
- Check the setting of BALANCE for AUDIO menu. (See page 26.)

## **There is a picture but no sound.**

- Is the sound muted?
- Make sure the volume is not set to minimum.
- Are audio cables connected properly?
- Is the setting of INPUT SELECT on the SETUP menu correct? (See page 27.)

## **Unstable video.**

- The signal may be incompatible. (See page 41.)
- Try the automatic screen adjustment when the D-SUB are used. (See page 29.)

## **The video from the HDMI input terminal does not appear properly.**

- Is the setting for HDMI SETTING of INPUT SELECT on the SETUP menu correct? (See page 27.)
- Is the HDMI cable HDMI standard compliant? The monitor will not work with cables that are not standard compliant.
- Is the input signal compatible with this monitor? (See page 41.)
- To show 4K2K video or 1080p video, use a high-speed HDMI cable.
- If connected to a HDMI1 - 3 input terminal, connect to the HDMI4 input terminal. The video and audio of some connected devices may not output correctly because the HDMI1 - 3 input terminals support 3840 x 2160 (60Hz) 4:4:4 format. If input in this format is not necessary, use the HDMI4 input terminal. (See page 12.)

## **The video from PC D-Sub input terminal does not appear correctly.**

- Is the setting for SCREEN POSITION of INPUT SELECT on the SETUP menu correct? (See page 27.)
- Is the input signal compatible with this monitor? (See page 41.)

## **Control buttons do not work.**

### **There is no picture.**

- Load noises from outside may be interfering with normal operation. Turn off the power and turn it on after waiting at least 5 seconds, and then check the operation.

### **Power LED flashes red.**

- Hardware has a problem. Turn off the monitor and request repair from your SHARP dealer.

### **The monitor makes a cracking sound.**

- You may occasionally hear a cracking sound from the monitor. This happens when the cabinet slightly expands and contracts according to change in temperature. This does not affect the monitor's performance.

### **The Power LED is flashing in red and green alternately.**

- When the internal temperature of the monitor rises excessively, the brightness of the backlight decreases automatically in order to prevent high-temperature-related problems. If the internal temperature rises further, the monitor automatically enters standby mode and the Power LED blinks red and green alternately.
- Remove the cause of the excessive temperature rise.
  - If the monitor enters standby mode due to a rise in temperature, to return to normal display, turn the power switch off and then back on again. The monitor, however, will enter standby mode again if the cause of the temperature rise is not eliminated. (See page 8.)
  - Check whether the monitor is placed at a location where a quick rise in temperature is likely. Internal temperature rises quickly if the vents on the monitor are blocked.
  - Internal temperature rises quickly if dust accumulates inside the monitor or around the vents. Remove dust if possible. Ask SHARP dealer about removing internal dust.



When mounting the monitor, be sure to use a wall-mount bracket that complies with the VESA-compatible mounting method. SHARP recommends using M6 screws and tighten the screws. Note that screw hole depth of the monitor is  $\frac{3}{8}$  inch (10 mm). Loose mounting may cause the product to fall, resulting in serious personal injuries as well as damage to the product. The screw and hole should come together with over  $\frac{5}{16}$  inch (8 mm) length of thread. Use a bracket which has been approved for UL1678 standard, and which can endure at least 4 times or more the weight of the monitor.

### ■DDC (plug and play)

The monitor supports the VESA DDC (Display Data Channel) standard.

DDC is a signal standard for plug and play between monitors and computers. Information about resolution and other parameters is exchanged between the two. This function can be used if the computer supports DDC and it has been configured to detect plug-and-play monitors.

There are several types of DDC, depending on the communication method used. This monitor supports DDC2B.



You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.



# Mounting Precautions (For SHARP dealers and service engineers)

- When installing, removing or moving the monitor, ensure that this is carried out by at least 2 people.

- After mounting, please carefully ensure the monitor is secure, and not able to come loose from the wall or mount.
- Do not use any screw holes other than VESA holes for installation.
